In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of professional fee of **Rs.12,00,000/-** (Rupees Twelve Lakhs only) to **Sri Y.Rama Rao, Advocate, Hyderabad** towards fee for the work done till date and appearance on behalf of Telangana Power Utilities before Hon'ble Supreme Court of India in SLP (C) No.9243/2018 and batch filed by T.S power utilities with regard to final bifurcation of employees between T.S and A.P power utilities.
