## ORDER:

In reference 1st cited, it was ordered that, the Degrees/ Diplomas awarded to the programmes offered through Distance Education Mode by IASE, Rajasthan were not recognized degrees for recruitment, promotions, incentive increments or any other service benefits.

- 2. Sri. A. Mahikanth, AAE had acquired B.Tech (EEE) from IASE, Rajsathan and his case was not considered for appointment by transfer as AE in terms of orders issued vide reference 1<sup>st</sup> cited. Subsequently, as per the Hon'ble Supreme Court decision dated 03.11.2017 against Civil Appeal Nos: 17869-17870/2017 (Arising out of SLP (C) Nos: 19807-19808/2012), he had appeared for theory and practical examination conducted by AICTE on 03.06.2018 and 06.06.2018 in NIT, Warangal and he was declared as qualified in the first attempt with 41.2%. He has therefore requested vide reference 4<sup>th</sup> cited to consider him for appointment by transfer as AE from Sub Engineer notionally and to promote him as ADE duly revising seniority and pay accordingly as per the directions of Apex Court.
- 3. Further, in reference 5<sup>th</sup> cited, amendment orders were issued to the T.O.Os under references 1<sup>st</sup> & 2<sup>nd</sup> cited , stating that, the B.Tech Degree awarded by the Institute of Advanced Studies in Education (IASE), Sardarsahr, Rajasthan; shall be treated as valid for recruitment, promotions, incentive increments or any other service benefits, subject to the conditions mentioned therein.
- 4. After careful consideration and in compliance with the orders issued under reference 5<sup>th</sup> cited, Sri. A. Mahikanth, AAE/Maint.,/132/33KV SS/Imlibum, O/o CE/Metro Zone/Hyderabad shall be notionally appointed by transfer as Assistant Engineer on acquiring B.Tech from IASE, Rajasthan, as per Regulation 14(a) (1) of APSEB Service Regulations Part-II as adopted by TSTRANSCO with effect from 01-06-2007 allowing monetary benefit from the date of issue of these orders.

- 5. The above appointment by transfer orders shall be subject to the following conditions:
  - a. He shall be placed above Sri. K. Rajesh Babu, AE/Elecl and below Sri. V Ravindra Reddy AE/Elecl in the revised seniority list of AE/Elecl vide reference 3<sup>rd</sup> cited.
  - b. This appointment is purely temporary and do not confer any right for a regular appointment as Assistant Engineer / Electrical.
  - c. This appointment shall be liable for termination at any time without notice and without assigning any reasons therefor.
  - d. He should produce the original certificate of B.Tech/B.E./A.M.I.E in Engineering Graduation and S.S.C. (indicating the date of birth) etc., to the Chief Engineer, the Controlling Officer for verification.
  - e. The candidate shall have to pass the prescribed tests as per APSEB Service Regulations, as adopted by TSTRANSCO.
- 6. This order is issued with the concurrence of Joint Managing Director (Fin., Comml., & HRD), TSTRANSCO vide Regd. No.4264,dt. 22.11.2019.
