ORDER

The administrative approval was accorded for erection of 132/33 kV substation at Aipoor Village of Atmakoor (S) Mandal in Nalgonda District vide T.O.O. (CE-Transmission) Ms. No.195, Dated: 14.10.2015 for an amount of Rs.2132.12 Lakhs. The work was not taken up due to non availability of land and the substation site has changed to Nuthankal (V) & (M) in Survapet District.

- 2. The Superintending Engineer/ OMC/ Nalgonda has furnished the feasibility report for erection 132/33 kV Sub-Station at Nuthankal (V) & (M) in Suryapet District and the Chief General Manager/Projects/ TSSPDCL has furnished the 33 KV load data.
- 3. The Chief Engineer/ Power systems has conducted the load flow studies and communicated the study report stating that, considering system EHT losses, it is found to be technically feasible for erection of 132 kV DC/SC line from 400/220/132 kV Suryapet SS to the newly proposed 132/33 kV Nuthankal SS (in lieu of 132/33 kV Aipoor SS) in Suryapet District.
- The Chief Engineer / Telecom has furnished the detailed cost estimate for providing Optical Fiber Communication facility to the proposed 132/33 kV Nuthankal Sub-station.
- After careful consideration, TSTRANSCO accords administrative approval for the above scheme at a total cost of Rs.30.55 Crores including IDC considering latest approved material/ equipment rates, price escalation @ 10% & GST @ 18% as per the abstract.
