#### **ORDER:**

- 1) TSTRANSCO had filed a petition no. 2/TT/2019 for determination of Annual Transmission Charges (ATC) for Inter State Transmission System Lines between the states of Telangana and Andhra Pradesh for the FY 2016-17.
- 2) CERC issued orders dated 13.01.2020 in petition no. 2/TT/2019 for determination of Annual Transmission Charges for the FY 2016-17.
- 3) Now, TSTRANSCO has to file the petition for the five years Block period i.e., FY 2014-15 to FY 2018-19.
- 4) Since, previously 4 nos. ISTS lines between TS & AP and 1 no. ISTS line between TS & Karnataka were not included in the order issued by CERC dt. 13.01.2020 in Petition no. 2/TT/2019 for the FY 2016-17, it is now proposed to include the said 5Nos. lines in the present petition for determination of ATC for FY 2014-15 to FY 2018-19.
- 5) As per the CERC Regulations vide ref (2) cited, the fee for application for determination of Inter State Transmission tariff specified in clause (3) at 0.11 % of the ATC claimed by the petitioner for each year is calculated as follows:
