### **ORDER**

1. In the references 2<sup>nd</sup>, 3<sup>rd</sup> & 5<sup>th</sup> cited, orders were issued absorbing the outsourced peresonnal as Artisans Grade I to IV on contract “as is where is basis” temporarily directly by TSTRANSCO.

2. In the reference 4<sup>th</sup> cited, accept the offer of M/s. The United India Insurance Company Ltd. Hyderabad for providing of insurance premium for policy amount of Rs.10,00,000/- (Rupees Ten Lakhs only) to the Artisans with premium rate of Rs.472/- (Rs.400/- + GST 18% = Rs.472/-) per person per annum which includes all taxes and the policy shall cover the risk of Artisans of TSTRANSCO.

3. In the reference 7<sup>th</sup> cited, M/s.New India Assurance Company Ltd., quoted the lowest premium of Rs.325/- + GST 18% as applicable per person per annum for coverage of Rs.10,00,000/-(Rupees Ten Lakhs only) insurance for accidental death and disability including medical extension.

4. After careful examination, the TSTRANSCO hereby accepts the offer of M/s.New India Assurance Company Ltd., Hyderabad for providing of Insurance premium for policy amount of Rs.10,00,000/-(Rupees Ten Lakhs only) to the Artisans with premium rate of Rs.383.50 (Rs.325/- + GST 18%) (Rupees Three Hundred Eighty Three and Fifty paise only) per person per annum which includes all taxes and the policy shall cover the risk of Artisans of TSTRANSCO. The amount of insurance payable under the said policy to cover, when an accidental injury and cause results (during the period of insurance) is as follows:

- a) Death : 100 % of Sum Insured
- b) Permanent Total Disablement : 100 % of Sum Insured
- c) Loss of two limbs/ Two eyes : 100 % of Sum Insured  
or one limb and one eye
- d) Loss of one limb or one eye: : 50 % of Sum Insured
- e) Permanent Partial Disablement : Varying % of Sum Insured as per policy (As per Doctors evaluation of Disability)
- f) Temporary Total Disablement : 1 % of Capital Sum Insured per week Subject to a maximum of Rs.5000 per week for a maximum period of 100 weeks. Sum insured is limited to 24 months gross income subject to Rs.5,00,000/-.
- g) Children Educational Benefit Rs.15000 for two dependent children below the age of 25 years.
- h) Funeral Expenses 2% of sum insured subject to Maximum of Rs.2500-00.
- i) Expenses for Emergency travel to place of Death by Family members Rs.2500-00.
- j) Accidental Medical Expenses Rs.50,000/- subject to Actual incurred, 40% of Valid claim amount.

Policy will not pay under below circumstances:

- Compensation under more than one clause for same period of disability not exceeding capital sum insured
- Any payment after admission of a claim for 50 % / 100 % of Capital Sum Insured
- Any claim in the same period of insurance exceeding the Capital Sum Insured
- Suicide attempt there at VD criminal breach of law accidental death/injury under influence of liquor/drugs
- Pregnancy related claim
- War and nuclear perils

**Premium:**

Premium amount is Medical extension: **Rs. 325/-** + GST 18% as applicable

**Sum insured :**

Capital sum insured per life is Rs.10,00,000/-.

5. All the Pay Drawing Officers are directed to send the list of Artisans to whom the salaries are paid from their pay unit to the Pay Officer/ TSTRANSCO/ Vidyut Soudha/Hyderabad for arranging consolidated premium amount to M/s.New India Assurance Company Ltd., Hyderabad with a copy to the Joint Secretary/Vidyut Soudha/ Hyderabad.
6. The Pay Officer TSTRANSCO/Vidyut Soudha/Hyderabad is directed to arrange the total premium amount to M/s.New India Assurance Company Ltd., Hyd.Divisional Office -610100, 2nd Floor, # 3-6-10, Anasuya Complex, Opp.TTD Kalyanamandapam, Himayathnagar, Hyderabad – 29 towards Coverage of insurance under Group Personal Accident to Artisans of TSTRANSCO for a period of one year i.e. from 25.01.2019 to 24.01.2020.
