**ORDER:**

Whereas, in compliance of the supplementary report dtd.11-03-2020 read with Final Report dtd.26-12-2019 of Justice Sri D.M.Dharmadhikari, Former Judge of Supreme Court & One Man Committee, the employees whose names are mentioned in the annexure I & II appended to this T.O.O. are finally allocated to TSTRANSCO with effect from the date of their joining on 16.03.2020 FN [15.03.2020 being Public Holiday]. Henceforth, they shall be governed by the Rules and Regulations of TSTRANSCO. The fixation of inter-seniority of the incumbents shall be fixed in the cadre as on 02-06-2014 and review of promotions and the conditions governing their service if any shall be issued separately.

2. Whereas the employees on their final allocation to TSTRANSCO are posted at the places indicated against their names as mentioned in the Annexure I & II appended, shall be treated to be on the rolls of TSTRANSCO with effect from 15.03.2020 F.N. Upon their final allocation to TSTRANSCO, they shall be governed by the APSEB SRs, as adopted by TSTRANSCO and amended from time to time. They shall not be entitled to any "Monetary Benefit" arising out of pay fixations on account of revision of pay scales or by way of notional promotion during the period from 02-06-2014 to 15-03-2020 A.N.

3. The concerned SR Maintaining Authority/Pay Drawing Officers are requested to obtain the Service Register [duly updated as on date of their relief on 14-03-2020], Last Pay Drawn Certificate, No Dues Certificate/amount of Loan outstanding, Leaves availed and Leaves available at their credit including pending disciplinary cases files if any. They are also requested to get transfer of the GPF amount at their credit as on 14-03-2020 and also transfer of pension contribution for the service rendered by them from the date of their initial appointment and up to the date of their relief in APTRANSCO on 14-03-2020 from the concerned Pay Drawing Officer of APTRANSCO, from where the above employees were relieved.

4. In the event of non-receipt of the particulars as mentioned in above Para, on time, the Pay Drawing Officers are directed to pay the salary based on the Pay and Allowances of APTRANSCO as per the Last Pay Drawn particulars as shown in their Pay Slip for the month of February, 2020 on self certification and regulate their Pay & Allowances accordingly.

5. They are further informed that the TSTRANSCO reserves the right to review/cancel the above orders, if the information furnished by them is found to be false at a later date.

6. They are directed to assume charge accordingly. They are also informed that no request for alternative posting or sanction of leave will be entertained.
