**ORDER :**

In the reference 1<sup>st</sup> cited, the SE/OMC/Karimnagar informed that Sri Late A Raj Kumar (TSTRSEOMCOKMR02972) who worked as Artisan Grade-I at 132/33 KV Mallaram SS was committed suicide at his house and expired on 07.11.2017. Sri. Amberi Laxminarayana, F/o Late Sri A Raj Kumar requested to provide a job to one of the family member and sanction of Rs.10 Lakhs towards Ex-gratia.

2. In the reference 2<sup>nd</sup> cited, the CE/Transmission/TSTRANSCO/VS/Hyderabad forwarded the letter of SE/OMC/Karimnagar along with the family members certificate dt.19.12.2017 issued by Tahasildhar, Siricilla Mandal and affidavit-cum-undertaking with regard to legal heir of Late A Raj Kumar, Artisan Grade-I for arranging ex-gratia of Rs.10 Lakhs.

3. In the 33<sup>rd</sup> Board meeting held on 15.06.2019, the issue for "providing ex-gratia & employment to one of the Sister of Late A Raj Kumar (TSTRSEOMCOKMR02972) who worked as Artisan Grade-I at 132/33 KV Mallaram SS committed suicide and expired on 07.11.2017" was discussed and decided to provide only the ex-gratia "to the family of deceased Artisan as a special case".

3. After careful examination, TS Transco hereby accords sanction for a sum of Rs.10,00,000/- (Rupees Ten Lakhs only) as ex-gratia on humanitarian grounds towards final settlement to Legal heir Sri.Amberi Laxminarayana (Father) of the deceased Late Sri A Raj Kumar (TSTRSEOMCOKMR02972) who worked as Artisan Grade-I at 132/33 KV Mallaram SS committed suicide at his house and expired on 07.11.2017.

4. The Chief Engineer/Karimnagar Zone/TSTRANSCO/Karimnagar is directed to take necessary action subject to the following conditions.
- a) The payment should be made without admitting any legal liability.
  - b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
  - c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
  - d) Withdrawing cases filed against Asst. Engineer, 132 KVSS Mallaram, at police stations and court.
