- 1. Administrative approval was accorded for erection of 220/132 kV Sub-Station at Ammavaripet, Kazipet (M) in Warangal Urban District vide T.O.O (CE-Construction) Ms. No 95, Dated: 02.05.2018 for an amount of Rs. 126.91 Crores.
- 2. The Chief Engineer/Warangal Zone has submitted the proposal for laying of Multi-circuit towers for accommodating the 132 KV lines to 132 KV SS Inavole & Wardhannapet to avoid the Right of way problems during the execution of work. The approval was accorded for the following 132 KV lines on 12.11.2018
 - Erection of 132 KV Multi-circuit towers for a length of 6.98 KM for accommodation of 132 KV Line to 132KV SS Inavole and 132KV Line to 132KV SS Wardhannapet from the proposed 220/132 kV Sub-station Ammavaripet to AP.8.
 - ii. Erection of 132 kV DC/SC Line on Galvanized Towers with Panther ACSR Conductor from the AP.8 to the 132/33 kV SS Inavole for a length of 2.32 KM.
 - Erection of 132 kV DC/SC Line on Galvanized Towers with Panther ACSR Conductor from the AP.8 to the 132/33 kV SS Wardhannapet for a length of 16.25 KM.
 - iv. Erection of 132 kV DC Line on Galvanized Towers with Panther ACSR Conductor from the proposed 220/132 kV Sub-station Ammavaripet to the existing 132/33 kV Sub-Station, Geesukonda for a length of 23 KM.
- 3. The estimated cost for the revised proposal considering latest approved rates works out to Rs.126.86 Crores including IDC with laying of 132 KV Multi circuit line. The cost data for 220 KV substation and connected lines remains unaltered.
- 4. After careful consideration, TSTRANSCO accords revised administrative approval for erection of 220/132 kV Sub-Station at Ammavaripet, Kazipet (M) in Warangal Urban District for an amount Rs.126.86 Crores (Rupees One Hundred and Twenty Six Crores and Eighty Six Lakhs) as per the abstract.
