## ORDER:-

In the G.O. 13th cited, the Government of Telangana under the provision of Section 4 and 5 of the Telangana Disaster Management and Public, Health Emergency (Special Provisions) Act, 2020, ordered to release the deferred pay, pension or remuneration, payable for the months of March, April and May'2020 to all the State Government Employees including AIS Officers, Public Representatives and Pensioners and also in respect of employees of all PSUs.

- 2. In T.O.O.'s 2<sup>nd</sup>, 3<sup>rd</sup> and 7<sup>th</sup> cited, orders were issued for deferment of Consolidated Remuneration / Honorarium / Salaries / Wages / Pensions in respect of Directors / OSDs / Employees / Artisans / Pensioners / Outsourced & Contract Employees of TSTRANSCO from the gross salary for the months of March'2020, April'2020 & May'2020.
- 3. In the references 8th, 9th and 10th cited, orders were issued to all the Pay Drawing Officers of TSTRANSCO/ TSGENCO / TSSPDCL & TSNPDCL to deduct One Day's Basic Pay/Pension from all the Employees/Artisans/Pensioners while releasing the deferred Salary/Wage/Pension of March'2020 payable in April'2020 for donating in favour of "CM Relief Fund" to meet the COVID-19 relief measures in the State of Telangana.
- 4. As per the Final Report of One Man Committee of Justice Sri D.M.Dharmadhikari dt.26-12-2019 certain employees were allotted from APTRANSCO to TSTRANSCO vide T.O.O. 4th and 5th cited. In Memo 6th cited working instructions were issued to the Pay Drawing Officers of TSTRANSCO for payment of Pay and Allowances to the said employees.
- 5. After careful examination, TSTRASNCO hereby directs all the Pay Drawing Officers of TSTRANSCO to pay the deferred consolidated remuneration / Honorarium / Salaries / Wages / Pensions for months of March'2020, April'2020 & May'2020 in the following manner:
  - a. The deferred Consolidated Remuneration / Honorarium / Salaries due for the months of March, April & May'2020 shall be paid in **four equal instalments** commencing from the pay bills of October'2020 payable in November'2020 in respect of Directors / OSDs / Class-III and above Employees of TSTRANSCO, duly deducting one day's basic pay from the Class-III and above Employees deferred in the month of March'2020 i.e., as per the orders issued in references 8th and 9th cited.

- b. The deferred Salaries / Wages due for the month of March'2020 shall be paid in one instalment along with the pay bills of October'2020 payable in November'2020 in respect of Class-IV/O&M/ Artisans / Outsourced & Contract Employees of TSTRANSCO, duly deducting one day's basic pay of Class-IV/O&M and Artisans deferred in the month of March'2020 i.e., as per the orders issued in TOO 8th & 9th cited.
- c. The deferred Pension due for the months of March, April & May'2020 shall be paid in two equal instalments commencing from the pay bills of October'2020 payable in November'2020 in respect of all Pensioners of TSTRANSCO, duly deducting one day's basic pension deferred in the month of March'2020 i.e., as per the orders issued in TOO 10th cited.
- Further all the Pay Drawing Officers of TSTRANSCO shall follow the orders mentioned at para-5 above in respect of employees who were allotted from APTRANSCO to TSTRANSCO vide T.O.O. 4th and 5th cited.
- These orders are issued with the concurrence of Jt.Managing Director (Fin., Comml., & HRD) vide Regd.No.3823, dt.07.10.2020.
