TSTRANSCO – IR – Payment of Employees Compensation to Dependent Legal Heirs of Deceased Artisan Late Sri G.Naresh, S/o.Shankaraiah, Artisan Grade-III who worked in CBD Lines, Shapurnagar, O/o.SE/OMC/Metro-West/Hyderabad and expired due to Departmental Fatal Accident on 27.09.2023 at 13.27 Hrs. – Sanction – Accorded.

ORDER:

In the reference 2nd cited, the Chief Engineer/Transmission/VS/Hyderabad has enclosed the detailed report of Chief Engineer/Metro Zone/Hyderabad furnished vide reference 1st cited wherein it was submitted that fatal accident occurred to Sri G.Naresh, I.D.No.5000429, Artisan Grade-III on 27.09.2023 while carrying out tree cutting work on 220 KV Shapurnagar – Erragadda – Raidurg double circuit line. It was further informed that Sri G.Naresh, Artisan Grade-III was shifted to nearby Pratima Hospital where he was declared dead at 13.27 Hrs. In the representation 3rd cited, Smt.G.Neeraja, W/o.Late G.Naresh has requested to sanction eligible compensation benefits as her husband Late Sri G.Naresh, Artisan "Grade-III has expired in departmental fatal accident.

- 2. The Artisans and their dependents shall be entitled for payment of compensation under Workmen's Compensation Act 1923, in case of injury, disability or death by fatal accidents arising out of and in the course of employment as per the Clause 21 of Chapter-VI under heading "Employee Compensation" of Standing Orders, Service Rules & Regulations for Artisans working in TSTRANSCO.
- 3. After careful examination, TSTRANSCO hereby accords sanction a sum of Rs.14,59,800/- (Rupees Fourteen Lakhs Fifty Nine Thousand and Eight Hundred only) as workmen compensation towards final settlement to Legal Heir of Late Sri G.Naresh, I.D.No.50004629, Artisan Grade-III who expired on 27.09.2023 due to electric shock while cutting tree and fell down from tree and died.

- 4. The Chief Engineer/Metro Zone/TSTRANSCO/Hyderabad is directed to take necessary action subject to the following conditions.
 - a) Legal Heir certificate shall be obtained from the dependents of deceased Artisan issued by the concerned Government Authority.
 - b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
 - c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
 - d) The payment should be made without admitting an legal liability
