#### ORDER:

In the recent past there is an increase of Legal Matters and Cases to be dealt by TSTRANSCO/TSPCC & TSDISCOMS before various forums like CERC, APTEL, TSERC, etc., along with High Court and Supreme Court. Considering the manifold increase of Legal Issues, there is a need to form a separate Legal Cell consisting of a Law Officer and an Assistant Law Officer to effectively deal with all Legal Matters, which involve assisting in drafting of Affidavits/Counter Affidavits, Filing of Legal Cases, Implementation of Court Orders and Connected Activities in Consultation with the Advocates/Senior Advocates involved in the matters and also in Co-ordination with the Officials dealing with such subjects.

TSTRANSCO/TSPCC, after careful examination hereby orders that a Legal Cell shall be formed with a Law Officer and Assistant Law Officer to deal with Legal Matters pertaining to TSTRANSCO and TSPCC before various forums like CERC, APTEL, TSERC, etc., along with High Court and Supreme Court with immediate effect.
- 3. It is further ordered that Sri.M.Srinivasa Reddy, Personnel Officer (Legal & RTI) and Kum C.Manognya, Junior Personnel Officer (Legal & RTI) shall act as Law Officer and Assistant Law Officer respectively, in addition to their existing works of Legal Section and shall continue to do so under the existing hierarchy. These employees are placed under the direct control of Joint Managing Director (Finance, Commercial & HRD) to the extent of newly formed Legal Cell works i.e., Legal Matters pertaining to TSTRANSCO and TSPCC before various forums like CERC, APTEL, TSERC, etc., alongwith High Court and Supreme Court with immediate effect.
- 4. The subject of RTI will be attached to Personnel Officer (Regulations) O/o.Joint Secretary/TSTRANSCO, Vidyut Soudha, Hyderabad.
