ORDER:

Whereas, the Government of Telangana, published the Telangana Public Employment (Regulation of Age of Superannuation) Act, 1984 (Telangana Act.3 of 2021) (Amendment) Act, 2021 in the Telangana Gazette enhancing the Age of Superannuation of all Government employees from 58/60 years to 61 years, in view of the assent of the said Act by the Governor of Telangana on 27.03.2021.

- 2. Whereas, the Government of Telangana, in exercise of powers, conferred by Sub-section (2) of Section 1 of Telangana Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2021, appointed 30th day of March, 2021 as the date on which the said Act shall come into force.
- 3. Whereas, the Government of Telangana, Finance (HRM.III) Department, further issued orders vide Cir.Memo No.705517/161/A1/HRM-III/2020, Dt.4.4.2021, as to the adoption of the Telangana Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2021(Telangana Act.3 of 2021), by the other Organisations under the Government with regard to the Enhancing the Age of Superannuation from 58/60 years to 61 years to the employees under their control.
- 4. Whereas, the Energy Dept., Government of Telangana grated approval vide Letter No. Energy-HR/A1/LAQs/7/2021-HR, dated.08.04.2021, to adopted the Telangana Public Employment (Regulation of Age of Superannuation) Act, 1984 as amended by Telangana Act. No.03 of 2021 enhancing the age of superannuation from 58/60 years to 61 years in respect of all the employees working in TSTRANSCO with effect from 30th March, 2021.
- 5. Whereas, the Telangana Public Employment (Regulation of age of Superannuation) Act, 1984 as amended by Telangana Act No.3 of 2021 is adopted by the TSTRANSCO in the reference 8th read above enhancing the age of superannuation from 58/60 years to 61 years with effect from 30th March, 2021.

6. Accordingly, the following Amendment is issued to the Standing order No.46 of Chapter XIV of the "Standing Orders, Service Rules and Regulations for Artisans":

CHAPTER XIV - Standing Orders No.46 - Age of Superannuation:

The age of retirement shall be 58 years i.e. from the Afternoon of the last day of the month in which an Artisans Completes the age of Fifty eight years.

In place of the existing Standing Order No.46 as above, the following shall be substituted:

CHAPTER XIV - Standing Order No.46 - Age of Superannuation:

"The age of retirement shall be 61 years i.e., from the Afternoon of the last day of the month which an Artisan completes the age of 61 years"
