TSTRANSCO - IR - Payment of Employees Compensation to the Legal Heir of the deceased Late Sri H.Bhaskar, Artisan Grade-II (TSTRSEOMCOADB01918) worked at 132 KV Adilabad SS - Expired due to Departmental Fatal Accident on 20.12.2021 - Sanction - Accorded.

ORDER:

In the letter cited, the Superintending Engineer/OMC/Adilabad has informed that Sri H.Bhaskar (I.D.No.TSTRSEOMCOADB01918) working as Artisan Grade-II at 132 KV SS Adilabad while discharging his duties (rectifying the line isolator) at 132 KV SS Adilabad, suddenly fallen on ground and gone to unconscious. He was admitted in Govt. RIMS, Adilabad on 13.12.2021 and due to severity of accident he was shifted to Medicover Hospital, Hitech City, Hyderabad for better treatment as per Doctors Advice. Unfortunately he was expired on 20.12.2021. Superintending Engineer/OMC/Adilabad has further informed that Smt.H.Vijaya Laxmi, W/o.Late H.Bhaskar, Artisan Grade-II is requesting for sanction of compensation and terminal benefits.

- 2. The Artisans and their dependents shall be entitled for payment of compensation under Workmen's Compensation Act 1923, in case of injury, disability or death by fatal accidents arising out of and in the course of employment as per the Clause 21 of Chapter-VI under heading "Employee Compensation" of Standing Orders, Service Rules & Regulations for Artisans working in TSTRANSCO.
- 3. After careful examination, TSTransco hereby accorded sanction a sum of Rs.12,93,900/- (Rupees Twelve Lakhs Ninety Three Thousand and Nine Hundred only) as workmen compensation towards final settlement to Legal Heir of Late Sri H.Bhaskar (I.D.No.TSTRSEOMCOADB01918), Artisan Grade-II who expired on 20.12.2021 due to Departmental Fatal Accident while rectifying line isolator at 132 KV SS Adilabad.
- 4. The Chief Engineer/Karimnagar Zone/TSTRANSCO/Karimnagar is directed to take necessary action subject to the following conditions.
 - a) Legal heir certificate shall be obtained from the dependents of deceased Artisan issued by the concerned Government Authority.
 - b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
 - c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
 - d) The payment should be made without admitting an legal liability
