ABSTRACT

Establishment - TSTRANSCO - Bifurcation of Employees - Payment of Salaries/Pension to 584 employees relieved from A.P. Power Utilities to comply with the orders of the Hon'ble Supreme Court of India dt.08.04.2020 in M.A.No.915/2018 (915/2020) for the Month of April 2020 -Orders -

- 4. Clarification Order dated 13.3.2020 to Supplementary Report dated 11.3.2020 to Final Report dated 26.12.2019 of Hon'ble One Man Committee.
- 5. Order dt.08.04.2020 in MA No.915/2018 in MA No.60/2020 in Civil Appeal No.11435/2018 of Hon'ble Supreme Court of India.

ORDER:

The Hon'ble Supreme Court of India by its orders dtd.08-04-2020 in Miscellaneous Application No.915/2018 (915/2020) in Miscellaneous Application No.60/2020 in C.A.No.11435/2018 granted interim directions. The relevant portion of the Order are read as follows:

"One Man Committee in the above circumstances has submitted an application for permitting joining by passing an order of this Court with direction that service records of allocated employees to each side of the States may be made available online to the concerned Power Utility and, on the basis of such available records to the Employees Identity Number, the employees be paid monthly salary/pension last from until normal life in the country is restored and the allocation process by joining and posting of the employees is completed."

- Whereas, the Telangana Power Utilities have filed M.A.No.920/2020 seeking 2. clarification of the Order dtd.08-04-2020 in MA.No.915/2020 and the same is pending before the Hon'ble Supreme Court.
- Whereas, Telangana Power Utilities have submitted objections with regard to 584 employees relieved by the AP Power Utilities on the basis of unilateral proceedings of Sub-Committee Member representing on behalf of AP Power Utilities dtd.12-03-2020.
- Whereas, the 584 employees relieved by AP Power Utilities are not in conformity 4. with the One Man Committee Clarification Order dtd.13-03-2020 read with Supplementary Report dtd.11-03-2020 and Final Report dtd.26-12-2019 and that objections have been submitted to the Hon'ble One Man Committee by the Telangana Power Utilities. Further, some of the 584 employees have also attained the age of superannuation and their Pension details are not made available.
- Whereas, Telangana Power Utilities have admitted 71 Employees of A.P.Power Utilities who are satisfying the modalities as per the supplementary report of the One Man Committee dated 11.3.2020 and issued necessary posting orders.

- 6. Whereas, Andhra Pradesh State Electricity Relieved Employees Joint Action Committee addressed a letter to the AP Power Utilities to re-examine the issue and arrange to cancel the relieving orders issued in respect of 390 employees of A.P who have opted to A.P. and to retain and permit them to join duty in AP Power Utilities.
- 7. Whereas, the Employees of A.P.S.P.D.C.L relieved employees have addressed to the Hon'ble Justice Sri D.M. Dharmadhikari, that the relieving orders were issued against the norms/guidelines/principles of Natural Justice and requested to take necessary immediate action for their retention in A.P.S.P.D.C.L. and do justice in that regard.
- 8. Whereas, the State of Telangana issued guidelines regarding Payment of Salaries to the Public Sector Under takings and same is adopted by the TS Power Utilities in view of Pandemic Covid-19, for the month of April, 2020.
- 9. In view of the above, without prejudice to the rights of the Telangana Power Utilities and subject to the outcome of the final orders of the Hon'ble Supreme Court of India, it is decided to comply with the orders dtd.08-04-2020 of the Hon'ble Supreme Court in MA.No.915/2020 in MA.No.60/2020 in C.A.No.11435/2018 by releasing salary/pension to 584 Employees relieved by AP Power Utilities for the month of April, 2020, through TSPCC, as per the details furnished by A.P.Power Utilities.
- 10. The Payment of salary for the month of April, 2020 to these 584 employees does not confer on them any right whatsoever to claim or join duty in TS Power Utilities.
- 11. These orders are issued with the concurrence of JMD (Finance, Comml., & HRD) vide Regd.No.1790, dt.30.04.2020.
