ORDER:

In the reference 2<sup>nd</sup> cited, the Chief Engineer/ Karimnagar Zone/Karimnagar the representation dated 06.11.2023 enclosed Smt.B.Anitha. W/o.Late B.Ramesh, Artisan Grade-IV, O/o.SE/OMC/Karimnagar (expired while on duty on 25.10.2022) requesting for sanction of Compensation as per Workmen's Compensation Act 1923 as her husband Sri B.Ramesh, Artisan Grade-IV while working in CBD Gang in 220/132KV SS/Malyalapalli, O/o.SE/OMC/Karimnagar on 25.10.2022 accidently got electric shock and died while in duty.

- The Artisans and their dependents shall be entitled for payment of 2. compensation under Workmen's Compensation Act 1923, in case of injury, disability or death by fatal accidents arising out of and in the course of employment as per the Clause 21 of Chapter-VI under heading "Employee Compensation" of Standing Orders, Service Rules & Regulations for Artisans working in TSTRANSCO.
- After careful examination, TSTRANSCO hereby accords sanction a sum of Rs.11.98.500/- (Rupees Eleven Lakhs Ninety Eight Thousand and Five Hundred only) as workmen compensation towards final settlement to Legal Heir of Late Sri B.Ramesh, I.D.No.50002953, Artisan Grade-IV who expired on 25.10.2022 accidently got electric shock and died while in duty.
- The Chief Engineer/ Karimnagar Zone/ Karimnagar is directed to take 4. necessary action subject to the following conditions.
  - a) Legal Heir certificate shall be obtained from the dependents of deceased Artisan issued by the concerned Government Authority.
  - b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.

- c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
- d) The payment should be made without admitting an legal liability
