- 2) As per proviso in Clause (4)(2) of Regulation 2 of 2016 cited in Ref. (3) above, the Transmission Licensee should pay Annual Licence Fee @ Rs.2000/- per MW of Allocated Contracted Capacity as per the tariff order approved by the Hon'ble Commission before 15-04-2024.
- 3) Hon'ble TSERC has issued interim orders in I.A. No. 8 of 2024 in O.P. No. 3-2019 filed by TSTRANSCO for continuation of Transmission Tariff existing on 31-03-2024 from 01-04-2024 onwards until issue of final orders in the petition.
- 4) In view of the above, the annual licence fee for FY 2024-25 will be paid on approved contracted capacity for FY2023-24, i.e., 21866.04 MW which works out to Rs. 4,37,32,080 /- (Rupees Four Crore Thirty Seven Lakh Thirty Two Thousand Eighty only).
- 5) Approval is hereby accorded to release of an amount of Rs. 4,37,32,080 /(Rupees Four Crore Thirty Seven Lakh Thirty Two Thousand Eighty only)
