ORDER:

1. The Chief Engineer/Rural has stated that that the existing control house at 132kV SS Pashamailaram was constructed in 1998. The existing roof slab got damaged and also the reinforcement steel was completely deteriorated. The old control house slab has peeled off and the reinforcement has been corroded and is exposed at many places such as panel room, battery room, office room and toilets. Cracks are observed at the remaining places.
2. Hence it is proposed to dismantle the damaged roof slab and provide new RCC slab, beams, thereby utilizing the same brick masonry walls so that the same may be utilized as the extended portion of control room at the substation is not sufficient to accommodate the upcoming panels.
3. Accordingly, the Chief Engineer/Rural Zone has submitted an estimate for the work of “Renovation of control room by laying of roof slab (5 bays) by dismantling the existing damaged roof slab at 132KV Pashamailaram SS” and the same was scrutinized and the value of work comes to Rs. 38,00,000.00 (Rupees Thirty Eight Lakhs only)
4. Under the circumstances explained by the Chief Engineer / Civil and after careful consideration, TS Transco here by accords approval for taking up the work of “Renovation of control room by laying of roof slab (5 bays) by dismantling the existing damaged roof slab at 132KV Pashamailaram SS” for an amount of Rs. 38,00,000.00 (Rupees Thirty Eight Lakhs only) including Corpus Fund and GST Provisions.

5. The work will be taken up after allocation of necessary capital budget (Non-Plan) and sanction of the estimate.
