## ORDER

The administrative approval was accorded for erection of 132/33 kV SS at Addakal (V) & (M) in Mahabubnagar District vide T.O.O (CE-Transmission) Ms.No.80, Dated: 23.05.2017 for an amount of Rs.1744.00 Lakhs. The work was not taken up due to non availability of land and the substation site has changed to Vemula (V), Addakal (M) in Mahabubnagar District.

- The Chief Engineer/ Rural Zone has furnished the feasibility report and the Chief General Manager/Projects/ TSSPDCL has furnished the 33 KV load data for erection of 132/33 kV Sub-Station at Vemula (V), Addakal (M) in Mahabubnagar District.
- 3. The Chief Engineer/ Power systems has conducted the load flow studies and communicated the study report stating that, the proposal for erection of 132/33kV SS at Vemula is found to be required & considering system EHT losses, it is found to be technically feasible for 132 kV DC/SC line from 132/33kV SS Khillaghnapur to the proposed 132/33 kV SS Vemula (V), Addakal (M) in Mahabubnagar District.
- The Chief Engineer/ Telecom has furnished the detailed cost estimate for providing Optical Fiber Communication facility to the proposed 132/33 kV Vemula Sub-station.
- After careful consideration, TSTRANSCO accords administrative approval for the above scheme at a total cost of Rs.32.92 Crores including IDC considering latest approved material/ equipment rates, price escalation @ 10% & GST @ 18% as per the abstract.
