## ORDER:

In the reference 3<sup>rd</sup> cited, Chief Engineer/Metro Zone/Hyderabad has enclosed the representation dated 05.12.2023 of Smt.Palli Sasikala requesting for sanction of Coverage of Accident Risk in Self Funding Scheme as per eligibility as ordered in reference 1<sup>st</sup> cited as her husband Sri Talla Veerraju, JLM/CBD/Moulali, O/o.SE/OMC/Metro-East/ Hyderabad who met departmental electrical fatal accident at 220 KV SS Moulali and expired on 18.11.2023 while undergoing treatment at M/s.Yashodha Hospitals, Secunderabad.

2. TSTRANSCO vide reference 1<sup>st</sup> cited has extended the period of one more year of Self Funding Scheme towards coverage of accidental risk for a maximum amount of Rs.5 Lakhs (Rupees Five Lakhs Only) in case of accidents occurred to the regular Employees working in TSTRANSCO for a period of one year from 01.11.2023 to 31.10.2023. The Sum Assured per Employee in Self Funding Scheme is Rs.5 Lakhs. 100% of Sum Assured is payable to Dependent Legal Heirs of Deceased Employee in case of death caused while on duty or otherwise covering Accident Death/Injuries due to Electrocution and other reason mentioned therein.
