ORDER:

In the T.O.O. 3rd cited, orders were issued for payment of Variable Dearness Allowance (Cost of Living Allowance) to the Outsourced Labour of O&M of EHT Substations and to the private security guards at certain EHT substations in TSTRANSCO w.e.f. 01.10.2022 to 31.03.2023.

- In the reference 4th cited, the Commissioner of Labour, Labour Department, Government of Telangana has notified that CPI points were increased from 1659 points to 1733 points (74 CLA points were increased) payable under Minimum Wages Act, 1948 and requested to implement the revised VDA w.e.f 01.04.2023 to 30.09.2023.
- After careful consideration, Transmission Corporation of Telangana Limited hereby 3. accords approval for payment of Variable Dearness Allowance (Cost of living allowance) to the outsourced labour for O&M of EHT Sub-stations and to the private security guards at Certain EHT Sub-Stations in TSTRANSCO with effect from 01.04.2023 to 30.09.2023 as detailed below:
