## ORDER:

In the T.O.O. 3rd cited, orders were issued for payment of Variable Dearness Allowance (Cost of Living Allowance) to the Outsourced Labour of O&M of EHT Substations and to the private security guards at certain EHT substations in TSTRANSCO w.e.f. 01.04.2021 to 30.09.2021.

- In the reference 4th cited, the Commissioner of Labour, Labour Department, Government of Telangana has notified regarding cost of living Allowance payable under Minimum Wages Act, 1948 that the VDA w.e.f 01.04.2021 will continue to be effective from 01.10.2021 onwards till further revision.
- After careful consideration, Transmission Corporation of Telangana Limited hereby accords approval for payment of Variable Dearness Allowance (Cost of living allowance) to the outsourced labour for O&M of EHT Sub-stations and to the private security guards at Certain EHT Sub-Stations in TSTRANSCO with effect from 01.10.2021 onwards till further revision as detailed below:
