**ORDER:**

2. After careful consideration, TSTRANSCO hereby accords sanction for an amount of Rs.10,00,000/- (Rupees Tenlakhs only) towards exgratia, as a special case on humanitarian grounds for final settlement to the Legal Heir of Late Sri M.Yedukondalu, S/o Nagaiah, Artisan Grade-IV (ID-TSTRSEONCOKMM04684), O/o SE/OMC/ Khammam.

3. The Chief Engineer / Warangal Zone / TSTRANSCO / Warangal is requested to take necessary action, subject to the following conditions:

- a) Payment should be made without admitting any legal liability.
- b) An undertaking from the legal heirs of the deceased Artisan shall be taken to the effect that there shall be no further liability to TSTRANSCO.
- c) Department Officers shall make the actual payments directly to the legal heirs and utmost care must be taken to ascertain the legal heir. Proper receipts should be obtained and dated acknowledgment/receipt for the amount received in full by the legal heirs as final settlement of claims against the TSTRANSCO.
