1. Administrative approval was accorded for construction of 132/33 KV Substation at Chinna Shankarampet in Medak District vide T.O.O (CE-Construction) Ms.No.124, Dt. 19.08.2017.
2. In this regard, the District Collector, Medak was requested to allot 10.00 acres of Government land in Chinna Shankarampet Mandal of Medak district for construction of 132/33 KV SS at China Shankarampet.
3. The District Collector, Medak vide letter dt.01.09.2018 has informed that Government assigned land is available at Shankarampet (R) village and Mandal in Sy No. 345 to an extent of Ac.10.12 gts and another bit adjacent to this land in Sy No. 366 to an extent of Ac.0.07 gts, total extent Ac.10.19 gts for construction of 132/33 KV Substation at China Shankarampet and assignees are willing to hand over their lands for construction of 132/33 KV Substation at market value i.e Rs. 6,00,000/- per acre.
4. Further, it was informed that due to non-availability of vacant Government land in Shankarampet (R) village the above assigned land to an extent of Ac.10.19 gts in Sy Nos 345 & 366 of Shankarampet (R) village is to be acquired from the assignees on payment of compensation under the RFCTLA & RR (Telangana Amendment) Act, 2016, at the prevailing market value of Rs. 6,00,000/- per acre and an amount of Rs. 62.85 Lakhs is needed for payment to the assignees for the required Ac.10.19 gts of land and therefore requested to deposit an amount of Rs. 62.85 Lakhs for payment of compensaton.
5. After careful consideration of the above proposal, the TSTRANSCO hereby authorize the Superintending Engineer, OMC Circle, Sangareddy to deposit an amount of Rs. 62.85 Lakhs (Rupees Sixty Two Lakhs Eighty Five thousands only) towards compensation to the assignees for acquisition of Ac. 10.19 gts of Government assigned land in Sy Nos 345 (Ac.10.12 gts) & 366 (Ac.0.07 gts) situated at Shankarampet(R) village and Mandal in Medak district for construction of 132/33 KV Substation at China Shankarampet.

6. The Expenditure for an amount of Rs. 62.85 Lakhs (Rupees Sixty Two Lakhs Eighty Five thousands only) shall be met from the TSTRANSCO funds.
