## ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Secunderabad has preferred (2) No. credit medical bills amounting to Rs.3,64,064/- (Rupees Three Lakhs Sixty Four thousand and Sixty Four only) towards the medical treatment extended to Sri L.Sampathi Rao, DE, I.D No.1010866 O/o. SE/OMC/Warangal as in-patient for the period from 9-8-2020 to 14-8-2020 for “LRTI?, Covid-19 Positive (Medical Management)” at Yashoda Hospitals, Secunderabad and requested to issue cheque in favour of M/s. Yashoda Health Care Services Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo. dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.3,20,020/- (Rupees Three Lakhs Twenty thousand and Twenty only) from SFMS for F.Y 2020-21 to M/s. Yashoda Hospitals, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.44,044/- (Rupee Forty Four thousand and Forty Four only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.

The Pay Officer/TS Transco/Vs/Hyderabad is requested to arrange for payment of Rs.3,20,020/- (Rupees Three Lakhs Twenty thousand and Twenty only) from SFMS for F.Y 2020-21 to Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidvut Soudha, Hyderabad.

4. An amount of Rs.3,13,851/- is sanctioned to Sri L.Sampathi Rao, DE, I.D No.1010866 O/o. SE/OMC/Warangal. A sum of Rs.6,169/- is recoverable from the Employee. The SE/OMC/Warangal is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
