The hospital should charge for all the Ayurvedic medicines/ Panchakarma procedures/ Diagnostic services including major ailments of Paralysis, Osteo and Rheumatoid Arthritis, Cervical and Lumbarspondilosis, Acute Bronchial Asthama, Sinusitis, Diabeticmelitis, Hypertension, Jaundice, Psoriasis, Obesity, Infertility, Gynecological all disorders, Stress and Strain, Psychological disorders and all allergic disorders etc., given as per the package rates as per G.O Ms.No.614, dt. 15-12-1999 and as prescribed by Govt. of Telangana i.e., Dept. of AYUSH from time to time.

- 4. The new recognition of the hospital will be considered and validity based on Govt. approval from time to time. The hospital shall apply for renewal well in advance from the date of its expiry.
- 5. The hospital authorities are advised to extend the medical facility to the TSTRANSCO Employees/Pensioners /Family Pensioners and their dependents whenever they approach for treatment.
