#### ABSTRACT

TSTRANSCO – IR – Self funding scheme towards providing accidental risk to the regular employees of TSTRANSCO for the period of one year from 01.11.2022 to 31.10.2023 – Orders – Issued.

#### ORDER:-

In the reference 2<sup>nd</sup> cited, the TSTRANSCO issued orders for the period of one year of Self Funding Scheme towards coverage of accidental risk for a maximum amount of Rs.5 lakhs (Rupees Five Lakhs only) in case of accidents occurred to the regular employees working in TSTRANSCO for a period of one year from 01.11.2021 to 31.10.2022 with contribution of Rs.155/- (Rupees One hundred and Fifty Five only) per employee working in TSTRANSCO by following the terms and conditions envisaged in T.O.O.(Jt.Secy-Per)Ms.No.395, dt.03.07.2019

2. After careful examination, TSTRANSCO hereby extend the period one more year of Self Funding Scheme towards coverage of accidental risk for a maximum amount of Rs.5 lakhs (Rupees Five Lakhs only) in case of accidents occurred to the regular employees working in TSTRANSCO for a period of one year from 01.11.2022 to 31.10.2023 with contribution of Rs.155/- (Rupees One hundred and Fifty Five only) per employee. The details of the scheme and amounts payable under the Self Funding Scheme towards coverage of accidental risk to the regular employee of TSTRANSCO are as follows:

### Contribution Details:

• Type of Cover : Accidental risk

• No. of Employees : 2579

SFS sum assured per employee : Rs. 5 Lakhs
 Period of Scheme : One Year

• Contribution per employee : 155/-

## Coverage:

The scheme provides accidental risk for death or disablement (Occurring within 12 months of bodily injury) due to solely or directly from accident caused by external, violent means.

 Loss of two limbs, two eyes or
 100% of sum assured amount.

• Loss of two limbs, two eyes or = 100% of sum assured as one limb and one eye

Loss of one limb or one eye
 Permanent Total Disability from

Injuries other than those named above.

The scheme covers the accidental risk on 24 hours basis whether the regular employees are on duty or otherwise covering Accidental Death /Injuries due to Electrocution, Accidental Falls, Road / Rail Accidents, Explosions, Drowning in Water, Snake Bite, Dog Bite, Riots, Action of Militants and Murders.

# Risk Exclusions in Brief:

Payment of Accidental Risk in respect of Death, Injury or Disablement of the Employees.

- a. from intentional self-injury suicide or attempted suicide.
- b. Whilst under the influence of intoxicating liquor or drugs.
- c. whilst engaging in aviation or ballooning or whilst mounting into dismounting from or traveling in any balloon or aircraft other than as passenger (fare paying or otherwise) in any duty licensed standard type of aircraft anywhere in the world.
- d. Arising or resulting from the insured person committing any breach of law with criminal intent.
- 3. The fund shall be kept under the control of FA&CCA (Accounts)/TSTRANSCO. The FA&CCA(Accounts) is hereby directed to operate the said fund towards accidental risk for the regular employees working in TSTRANSCO for the period of one year i.e. from 01.11.2022 to 31.10.2023.
- 4. The Heads of Departments of TSTRANSCO are hereby directed to obtain the claims alongwith F.I.R., Panchnama, Postmortem Report, Final Report, Death Certificate, Aadhar card, Legal heir certificate and other related documents towards accidental risks and shall submit to the Joint Secretary/TSTRANSCO within three (3) months in full shape from the date of occurrence of Death/Injury or Disablement for scrutiny.

- 5. All the Pay Drawing Officers of TS TRANSCO are directed to recover an amount of Rs.155/-(Rupees One Hundred and Fifty Five only) from the salary of Employees for the month of November 2022 payable in December 2022 from employee of TSTRANSCO and transfer the same to the Self Funding Scheme which is kept under the control of FA&CCA (Accounts)/TSTRANSCO.
- 6. The management reserves the right to roll back or dispense with the self-funding scheme towards accidental risk in case of accidents, if any, dispute or irregularities arises for implementation of the scheme.
- 7. This order is issued with the concurrence of the Joint Managing Director (Fin., Comml., & HRD)/vide Regd.No.4695, dt.04.11.2022.
