**ORDER:**

In the reference 1<sup>st</sup> cited, the Member Secretary, Southern Regional Power Committee (SRPC), Bangalore has informed that an amount of Rs.21,31,194/- towards Annual Expenditure for Southern Regional Power Committee (SRPC) for the Financial Year 2023-24 in favour of "SRPC Establishment Fund" is payable by TSTRANSCO towards its share and requested to arrange payment in the form of Demand Draft/NEFT/RTGS under intimation to SRPC.

2. Accordingly, in the reference 3<sup>rd</sup> cited, sanction was accorded for Rs.21,31,194/- (Rupees Twenty One Lakhs Thirty One Thousand and One Hundred and Ninety Four only) being the share of the TS TRANSCO (Two Members) towards Annual Expenditure for the financial year 2023-24.

3. In the reference 5<sup>th</sup> cited, the Chief Engineer/SLDC has informed that, Two Members from TSTRANSCO are representing in SRPC, so the amount payable is RS.42,62,388/- (Rupees Forty-Two Lakhs, Sixty-Two Thousand, Three Hundred and Eighty-Eight Only) of which the payment of Rs.21,31,194/- (Rupees Twenty-One Lakhs, Thirty-One Thousand, One Hundred and Ninety-Four Only) was paid and the confirmation was received from SRPC. In the reference 4<sup>th</sup> cited the SRPC has informed that the payment was made for single paying member and requested for arranging the payment of another paying member of Rs.21,31,194/- (remaining amount).

After careful consideration and in exercise of the powers conferred in B.P.Ms.No.605, Dt:9.8.1982 & Memo.No.Addl.Secy./DIR/AS(Reg.)/PO-1(2)/409/98-3, Dt:18.2.1999 as adopted by TSTRANSCO, sanction is hereby accorded for Rs.21,31,194/- (Rupees Twenty One Lakhs Thirty One Thousand and One Hundred and Ninety Four only) (remaining amount) of another Paying Member, towards payment of Annual Expenditure of SRPC for the Financial Year 2023-24.

5. The expenditure sanctioned above is debitable to A/c.Head - 760127 contributions.
