ORDER :

In T.O.Os under reference cited, orders were issued for appointment of Sri. T.Madhusudhan (who retired from services on attaining age of superannuation on 28.02.2018), as Officer on Special Duty to discharge the duties and responsibilities of CGM(HRD) for one year w.e.f, 01-03-2018 or until further orders whichever is earlier, with a remuneration of Last Pay Drawn minus pension limited to Rs.1,00,000/- (Rupees One Lakh only) per month.

2. Further, the issue of relieved employees is assigned to One man Committee of Sri. Dharmadhikari, Rtd Hon'ble Supreme Court Judge and the Committee hearings are under progress. Also, the recruitment of JLM, Sub-Engineer/Elecl, (for which written examinations were conducted in 2018) have to be taken up after getting orders from Hon'ble High Court on the cases pending against issues of assigning of weightage marks.

3. Taking into consideration the above position and after careful examination of the matter, TSTRANSCO hereby extends the period of appointment of Sri. T.Madhusudhan (who retired from services on attaining age of superannuation on 28.02.2018), as Officer on Special Duty to discharge the duties and responsibilities of CGM(HRD) for a further period of three months w.e.f, 01.03.2019 until 31.05.2019 or further orders whichever is earlier.
