ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Somajiguda, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.37,339/- (Rupees Thirty Seven thousand Three hundred and Thirty Nine only) towards the medical treatment extended to Smt. A.Pushpalatha, W/o. Sri V.Venkateswar Reddy, DE, I.D No.1016318 O/o. SE/OMC/Metro East/Hyderabad as inpatient from 26-8-2021 to 1-9-2021 for “Dengue Fever” at Yashoda Hospitals, Somajiguda, Hyderabad and requested to issue cheque in favour of Yashoda Super Speciality Hospital.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.37,334/- (Rupees Thirty Seven thousand Three hundred and Thirty Four only) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.5/- (Rupee Five only) towards the excess amount claimed by Yashoda Hospitals, Somajiguda, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.37,334/- (Rupees Thirty Seven thousand Three hundred and Thirty Four only) to Yashoda Super Speciality Hospital against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.36,027/- is sanctioned to Sri V.Venkateswar Reddy, DE, I.D No.1016318 O/o. SE/OMC/Metro East/Hyderabad. A sum of Rs.1,307/- is recoverable from the employee. The SE/Metro East/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
