In the reference 3rd cited, the Director, Yashoda Hospitals, Somajiguda, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.80,075/- (Rupees Eighty thousand and Seventy Five only) towards the medical treatment extended to Sri K.V.Ramakrishna, CE/Retd, I.D No.6500464 O/o. Pay Officer/ TSTransco/Vs/Hyd for “Allergic Bronchopulmonary Aspergillosis, BPH, COPD (MM)” as in patient from 20-10-2021 to 26-10-2021 at Yashoda Hospitals, Somajiguda, Hyderabad and requested to issue cheque in favour of Yashoda Super Speciality Hospital.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.79,724/- (Rupees Seventy Nine thousand Seven hundred and Twenty Four only) to Yashoda Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.351/- (Rupee Three hundred and Fifty One only) towards the excess amount claimed by Yashoda Hospital, Somajiguda, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.79,724/- (Rupees Seventy Nine thousand Seven hundred and Twenty Four only) to Yashoda Super Speciality Hospital against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.78,243/- is sanctioned to Sri K.V.Ramakrishna, CE/Retd, I.D No.6500464, O/o. Pay Officer/ TSTransco/VS/Hyd. A sum of Rs.1,481/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
