ORDER:

In the reference 3rd cited, the Director, Yashoda Hospital, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.34,881/- (Rupees Thirty Four thousand Eight hundred and Eighty One only) towards the medical treatment extended to Smt. D.Sattamma, W/o. Late D.Agamaiah, OS/Retd, I.D No.6600148 O/o. Pay Officer/TSTransco/VS/Hyd as in patient from 24-2-2022 to 1-3-2022 for “Gastro Esophageal Reflux (MM)” at Yashoda Hospital, Secunderabad and requested to issue cheque in favour of M/s. Yashoda Health Care Services Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.32,531/- (Rupees Thirty Two thousand Five hundred and Thirty One only) from General Ceiling to Yashoda Hospital, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.2,350/- (Rupees Two thousand Three hundred and Fifty only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.32,531/- (Rupees Thirty Two thousand Five hundred and Thirty One only) from General Ceiling to M/s. Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.30,917/- is sanctioned to Smt. D.Sattamma, W/o. Late D.Agammaiah, OS/Retd, I.D No.6600148 O/o. Pay Officer/TSTransco/VS/Hyd. A sum of Rs.1,614/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
