ORDER:

In the reference 3rd cited, the Director, Medicovert Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.79,810/- (Rupees Seventy Nine thousand Eight hundred and Ten only) towards the medical treatment extended to Sri O.Balaiah, SE, I.D No.1049788 O/o. CE/Power Systems/ TS Transco/ VS/Hyderabad as in patient from 4-3-2022 to 9-3-2022 for “Loose Stools, Hepativ, Metabolic Encephalopathy (MM)” at Medicovert Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad and requested to issue cheque in favour of “Sahrudaya Health Care Pvt. Ltd”.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.78,879/- (Rupees Seventy Eight thousand Eight hundred and Seventy Nine only) from General Ceiling to Medicover Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.931/- (Rupees Nine hundred and Thirty One only) towards the excess amount claimed by Medicover Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.78,879/- (Rupees Seventy Eight thousand Eight hundred and Seventy Nine only) from General Ceiling to Sahrudaya Health Care Pvt. Ltd against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco/Vidyut Soudha/ Hyderabad.

4. An amount of Rs.71,198/- is sanctioned to Sri O.Balaiah, SE, I.D No.1049788 O/o. CE/Power Systems/ TS Transco/ VS/Hyderabad. A sum of Rs.7,681/- is recoverable from the employee. The SAO/SLDC/VS/Hyderabad is requested to recover the amount accordingly in installments from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco., within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
