ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad has preferred (3) No. credit medical bills amounting to Rs.92,589/- (Rupees Ninety Two Thousand Five Hundred and Eighty Nine only) towards the medical treatment extended to Kum. Ayesha Fatima, D/o. Sri Md. Hasan Mohiddin, Artisan, Gr.II, I.D No.5243 O/o CGM(HRD)/TS Transco/VS/Hyderabad as inpatient from 27-11-2021 to 1-12-2021, 11-1-2022 to 14-1-2022 & 19-1-2022 to 21-1-2022 for “Covid Positive” at Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyd and requested to issue Cheque in favour of Lotus Children Hospital.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.60,061/- (Rupees Sixty Thousand and Sixty One only) from SFMS F.Y 2021-22 to Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.32,528/- (Rupee Thirty Two Thousand Five Hundred and Twenty Eight only) towards the excess amount claimed by Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.60,061/- (Rupees Sixty Thousand and Sixty One only) to Lotus Children Hospitals (A unit of Sri Viswa Medicare Ltd.) against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.50,856/- is sanctioned to Sri Md. Hasan Mohiddin, Artisan, Gr.II, I.D No.5243 O/o CGM(HRD)/TS Transco/VS/Hyderabad. A sum of Rs.9,205/- is recoverable from the Artisan. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
