ORDER:

In the reference 3rd cited, the Director, Maxcure Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.45,084/- (Rupees Forty Five Thousand and Eighty Four only) towards the medical treatment extended to Smt. C.Salamma, M/o. Sri C.Srinivas, Artisan, Grade-II, I.D No.50004357 O/o. CE/Civil/C&M/VS/Hyderabad as in patient from 21-4-2022 to 26-4-2022 for “CVA, Spastic Quadriparesis (MM)” at Maxcure Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad and requested to issue cheque in favour of “Sahrudaya Health Care Pvt. Ltd”.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.44,734/- (Rupees Forty Four Thousand Seven Hundred Seven Hundred and Thirty Four only) from SFMS F.Y 2022-23 to Maxcure Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupees Three Hundred and Fifty only) towards the excess amount claimed by Maxcure Hospital (A unit of Sahrudaya Health Care Pvt. Ltd.), Madhapur, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.44,734/- (Rupees Forty Four Thousand Seven Hundred and Thirty Four only) from SFMS F.Y 2022-23 to Sahrudaya Health Care Pvt. Ltd against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco/Vidvut Soudha/ Hyderabad.

4. An amount of Rs.44,219/- is sanctioned to Sri C.Srinivas, Artisan, Grade-II, I.D No.50004357 O/o. CE/Civil/C&M/VS/Hyderabad. A sum of Rs.515/- is recoverable from the Artisan. The Pay Officer/TSTransco/VS/Hyderabad is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco., within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
