In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Secunderabad has preferred (2) No. credit medical bills amounting to Rs.1,35,341/- (Rupees One Lakh Thirty Five Thousand Three Hundred and Forty One only) towards the medical treatment extended to Sri G.Naveen, Artisan, Grade-I, I.D No.50005480 O/o. SE/CTI & Enq./Hyderabad as inpatient from 5-5-2022 to 10-5-2022 and on 13-6-2022 for “URSL DJ Stenting, Uretric Calculus” at Yashoda Hospitals, Secunderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo. dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,17,255/- (Rupees One Lakh Seventeen Thousand Two Hundred and Fifty Five only) from SFMS 2022-23 to Yashoda Hospitals, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.18,086/- (Rupees Eighteen Thousand and Eighty Six only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,17,255/- (Rupees One Lakh Seventeen Thousand Two Hundred and Fifty Five only) from SFMS 2022-23 to Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.1,16,918/- is sanctioned to Sri G.Naveen, Artisan, Grade-I, I.D No.50005480 O/o. SE/CTI & Enq./Hyderabad. A sum of Rs.337/- is recoverable from the Artisan. The CE/CTI/TS Transco/Hyderabad is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items in instalments and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
