## ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.25,358/- (Rupees Twenty Five Thousand Three Hundred and Fifty Eight only) towards the medical treatment extended to Smt. G.Surya Kumari, W/o. Sri K.V.Somayajulu, SAO, I.D No.1058713 O/o. SE/OMC/Metro Central/ Hyderabad as inpatient from 6-7-2022 to 8-7-2022 for "Posterior Circulatory Stroke MM" at Yashoda Hospitals, Secunderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo. dt. 22-10-2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.25,008/(Rupees Twenty Five Thousand and Eight only) from General Ceiling to Yashoda Hospitals, Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupees Three Hundred and Fifty only) towards the excess amount claimed by Yashoda Hospitals, Secunderabad.
- 3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.25,008/-(Rupees Twenty Five Thousand and Eight only) from General Ceiling to Yashoda Health Care Services Pvt. Limited against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
- 4. An amount of Rs.24,651/- is sanctioned to Sri K.V.Somayajulu, SAO, I.D No.1058713 O/o. SE/OMC/Metro Central/ Hyderabad. A sum of Rs.357/- is recoverable from the Employee. The SE/OMC/Metro Central/Hyderabad is requested to recover the amount accordingly from the salary of the employee towards the cost of inadmissible items in instalments and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the Employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
