Pay Officer/TSTransco/VS/Hyd as inpatient from 23-6-2022 to 25-6-2022 and from 1-7-2022 to 11-7-2022 for "Hypoglycemia Ultered Sensorium (MM)" and "Hypoglycemia, Seizures, Dyselectrolytemia (MM)" at Prathima Hospitals (A unit of Sri Balaji Health Care India Pvt. Ltd.), Kachiguda, Hyderabad and requested to issue cheque in favour of Prathima Hospitals.
