ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.76,091/- (Rupees Seventy Six Thousand and Ninety One only) towards the medical treatment extended to Sri K.V.Ramakrishna, CE/Retd ID No.6500464 O/o. Pay Officer/TSTransco/VS/Hyd as in patient from 15-7-2022 to 22-7-2022 for “Acute Febrile Illness (MM)” at Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad and requested to issue cheque in favour of M/s. Yashoda Super Speciality Hospital.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.75,740/- (Rupees Seventy Five Thousand Seven Hundred and Forty only) from General Ceiling to Yashoda Super Speciality Hospitals, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.351/- (Rupee Three Hundred and Fifty One only) towards the excess amount claimed by Yashoda Super Speciality Hospital, Somajiguda, Hyd.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.75,740/- (Rupees Seventy Five Thousand Seven Hundred and Forty only) from General Ceiling to M/s. Yashoda Super Speciality Hospital against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.73,255/- is sanctioned to Sri K.V.Ramakrishna, CE/Retd ID No.6500464 O/o. Pay Officer/TSTransco/VS/Hyd. A sum of Rs.2,485/- is recoverable from the Pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the Pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the Pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
