ORDER:

Under Regulation-14(a)(1) of TSTRANSCO Service Regulations Part-II, **02** Asst. Executive Engineers (Civil) are promoted as Executive Engineers (Civil) with effect from the date of assumption of charge.

- 2. The **02** Asst. Executive Engineers on promotion as Executive Engineers (Civil) as ordered in Para-1 above are transferred and posted to the place noted against their names in the Annexure appended to this order.
- 3. The Asst. Executive Engineers (Civil) are requested to assume charge on their promotion as Executive Engineers (Civil) at the place of posting indicated against their name, within 15 days from the date of issue of the orders. If they fail to join or evade joining within stipulated period or proceeding on leave from the date of receipt of this order, their right for promotion shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year, subject to availability of vacancy.
- 4. The promotions ordered in Para-1 above are subject to review as per the Clarification dtd.29.05.2021 issued by the Government of Telangana with regard to fixation of seniority based on "merit ranking"; and also in terms of the Circular Memo dtd.24-10-2019 issued by the Scheduled Castes Development Department, Government of Telangana on the implementation of the rule of reservation to SCs/STs in promotions conferring "consequential seniority" or otherwise and implementation of "catch-up rule".
