ORDER:

In the reference 3rd cited, the Director, Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.41,523/- (Rupees Forty One Thousand Five Hundred and Twenty Three only) towards the medical treatment extended to Baby E.Vishnurudh, S/o. Smt. A.Spandana, Artisan, Gr.I, I.D No.5475 O/o CE/Comml./TS Transco/VS/Hyderabad as inpatient from 8-9-2022 to 12-9-2022 for "Broncholitis (Medical Management)" at Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyd and requested to issue Cheque in favour of Lotus Children Hospital.

- 2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Deputy Secretary (HRD) hereby accords sanction for an amount of Rs.37,681/-(Rupees Thirty Seven Thousand Six Hundred and Eighty One only) from SFMS 2022-23 to Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.3,842/- (Rupee Three Thousand Eight Hundred and Forty Two only) towards the excess amount claimed by Lotus Hospitals (A unit of Sri Viswa Medicare Ltd.), Lakdikapool, Hyderabad.
- 3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.37,681/-(Rupees Thirty Seven Thousand Six Hundred and Eighty One only) from SFMS 2022-23 to Lotus Children Hospitals against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
- 4. An amount of Rs.36,074/- is sanctioned to Smt. A.Spandana, Artisan, Gr.I, I.D No.5475 O/o CE/Comml./TS Transco/VS/Hyderabad. A sum of Rs.1,607/- is recoverable from the Artisan. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly from the salary of the artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
