ORDER:

In the reference 3<sup>rd</sup> cited, the Director, Nizam's Institute of Medical Sciences, Panjagutta, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.27,527/- (Rupees Twenty Seven Thousand Five Hundred and Twenty Seven only) towards the medical treatment extended to Smt. P.Manjula M/o. Sri P.J.Prasanth Kumar, Artisan, Gr.III, ID No.4400 O/o. CE/SLDC/VS/Hyderabad for "Excision Biopsy" from 24-8-2022 to 25-8-2022 at Nizam's Institute of Medical Sciences, Panjagutta, Hyderabad.

2. After careful examination and as per Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Deputy Secretary (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.21,137/- (Rupees Twenty One Thousand One Hundred and Thirty Seven only) from SFMS 2022-23 to Nizam's Institute of Medica Sciences, Panjagutta, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.6,390/- (Rupee Six Thousand Three Hundred and Ninety only) towards the excess amount claimed by Nizam's Institute of Medica Sciences, Panjagutta, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.21,137/- (Rupees Twenty One Thousand One Hundred and Thirty Seven only) from SFMS 2022-23 to Nizam's Institute of Medica Sciences, Panjagutta, Hyderabad against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.19,777/- is sanctioned to Sri P.J.Prasanth Kumar, Artisan, Gr.III, ID No.4400 O/o. CE/SLDC/VS/Hyderabad. A sum of Rs.1,360/- is recoverable from the Artisan. The SAO/SLDC/VS/Hyderabad is requested to recover the amount accordingly in instalments from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TSTransco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
