The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,19,532/- (Rupees One Lakh Nineteen Thousand Five Hundred and Thirty Two only) from General Ceiling to Ozone Hospitals against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
