## <u>ORDER</u>:

In the reference 1<sup>st</sup> cited, orders were issued duly attaching 8 No's EHT Sub-stations and connected lines along with posts/staff (which are geographically falls in newly formed Rangareddy & Vikarabad Districts) hitherto under the jurisdiction of SE/OMC/Mahabubnagar to SE/OMC/Metro-West and SE/OMC/Metro-East.

- 2. In the reference 2<sup>nd</sup> cited, the SE/OMC/Mahabubngar has submitted that, due to handing over of 8 No's EHT Sub-stations, 19 No's JLM posts were diverted i.e., 15 to Metro-East & 4 to Metro-West circles and the vacant JLM posts in OMC Circle Mahabubnagar has become Nil. As per instructions, appointment orders were issued to 2 No's JLM, but there are no posts available to allot to them. Stating this, the SE/OMC/Mahabubnagar has requested to divert 19 No's JLM posts to Mahabubnagar Circle in order to appoint Junior Linemen at present and in further recruitments.
- 3. After careful examination, TSTRANSCO hereby orders that the 19 No's JLM posts which were earlier diverted to SE/OMC/Metro-West and SE/OMC/Metro-East due to the handing over of Sub-stations, shall be restored back to SE/OMC/Mahabubnagar and be utilized as follows:
