After careful examination and as per Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Deputy Secretary (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.34,690/- (Rupees Thirty Four Thousand Six Hundred and Ninety only) from General Ceiling to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupee Three Hundred and Fifty only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.
