**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.51,987/- (Rupees Fifty One Thousand Nine Hundred and Eighty Seven only) towards the medical treatment extended to Sri K.Srinivasulu, JLM, I.D No.1074200 O/o. SE/OMC/Metro East/TSTransco/Hyderabad for “DM, HTN, CVA, CKD, AV Fistula MM” as inpatient from 04-09-2023 to 06-09-2023 at Yashoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of Yashoda Health Care Services Pvt. Ltd.

2. After careful examination and as per Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with memo dt:22.10.2020 hereby accords sanction for an amount of Rs.51,286/- (Rupees Fifty One Thousand Two Hundred and Eighty Six only) from General Ceiling to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.701/- (Rupee Seven Hundred and One only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.51,286/- (Rupees Fifty One Thousand Two Hundred and Eighty Six only) from General Ceiling to Yashoda Health Care Services Pvt. Ltd. against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.51,006/- is sanctioned to Sri K.Srinivasulu, JLM, I.D No.1074200 O/o. SE/OMC/Metro East/TSTransco/Hyderabad. A sum of Rs.280/- is recoverable from the Employee. The SE/OMC/Metro East/Hyderabad is requested to recover the amount accordingly from the salary of the employee towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
