**ORDER:**

In the reference 4<sup>th</sup> cited, the Director, KIMS Hospitals, Secundrabad, has preferred (3) Nos. credit medical bill amounting to Rs.86,165/-(Rupees Eighty Six Thousand One Hundred and Sixty Five only)(3Bills) towards the medical treatment extended to Sri.K.Maheshwara Rao, ADE(Retd), ID.No.1030350, O/o.SE/OMC/TSTransco/Sangareddy, as in-patient from 25.01.2024, 09.02.2024 & 24.02.2024 for “Metastatic Nasopharygeal Carcinoma (Cycle-5 Day-1, Day-8 MM & Cycle – 6)” at KIMS Hospitals, Secundrabad, and requested to issue a cheque in favour of “M/s Kishna Institute of Medical Sciences Limited.”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the Chief General Manager(HRD) hereby accords sanction for an amount of Rs.84,964/- (Rupees Eighty Four Thousand Nine Hundred and Sixty Four only)(3Bills) for reimbursement of medical charges to KIMS Hospitals, Secundrabad, in full and final settlement of credit bills towards the medical charges mentioned in para 1 duly deducting an amount of Rs.1,201/- (Rupees One Thousand Two Hundred and One only) towards the excess amount claimed by KIMS Hospitals, Secundrabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.84,964/- (Rupees Eighty Four Thousand Nine Hundred and Sixty Four only) (3 Bills) from major ceiling to M/s Kishna Institute of Medical Sciences Limited., against their credit bills under intimation to the Chief General Manager (HRD)/TSTransco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.84,347/- is sanctioned to Sri.K.Maheshwara Rao, ADE(Retd), ID.No.1030350, O/o.SE/OMC/TSTransco/Sangareddy. A sum of Rs.617/- is recoverable from the Pensioner the SE/OMC/TSTransco/Sangareddy is requested to recover amount in instalments from the pension accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager (HRD) TSTransco within a month from the last date of recovery from the Pension of the Pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officer.
