**ORDER:**

In continuation to the orders issued in the reference 5<sup>th</sup> cited, the Director, Yashoda Hospitals, Malakpet, Hyderabad was sanctioned with an amount of Rs. 3,57,259/- (Rupees Three lakh fifty seven thousand two hundred and fifty nine only) against the credit bill of Rs. 4,21,960/- towards the medical treatment extended to Smt.A.Sathyamma, M/o.Sri A.Yadagiri, Artisan Gr.II, ID.No.50000563, O/o.SE/400 KV Construction/Metro/Hyderabad as in-patient for the period from 26.09.2020 to 01.10.2020 for “**Acute GE, Covid-19 positive Ca.Cervix**” at Yashoda Hospitals, Malakpet, Hyderabad.

2. In the ref. 6<sup>th</sup> cited, the Director, Yashoda Hospitals, Hyderabad has requested to sanction the total credit bill claimed by them duly taking into consideration of global pandemic of Covid times.

After careful examination and as per the minutes of CMD/TSTransco under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD)/TSTransco hereby accords Revised sanction for an amount of Rs.64,701/- (Rupees Sixty Four thousand Seven hundred and One only) from SFMS for F.Y 2020-21 to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges which were deducted towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of balance amount of Rs.64,701/- (Rupees Sixty Four thousand Seven hundred and One only) to M/s.Yashoda Health Care Services Private Limited towards the medical charges which were deducted towards the excess amount claimed by them.
