ORDER:

Whereas, in the reference 2nd cited above, under Reg.14(a)(1) of TSTRANSCO SRs Part-II, the following 1 (One) ADE/Telecom was promoted temporarily as DE/Telecom from the panel drawn on 27.10.2016 keeping in view the exigencies of work and to suit administrative convenience:

- 2. The promotions ordered above were subject to the following conditions:
 - The promotion is temporary and liable for termination at anytime without (i) notice and without assigning any reasons thereto;
 - (ii) The promotion is subject to outcome of the Judgement in WP No. 16660 of 2015 and batch pending in Hon'ble High Court which is subject matter of CA No. 11435/2018 & Batch in the Hon'ble Supreme Court and also subject to outcome of Contempt Case (C) D.No. 28852/2020 in MA No. 1270/2020 in CA No. 11435/2018 & Batch.
 - (iii) The promotion is subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.
 - (iv) The promotion shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotions.

- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO&TSTRANSCO has attained finality. As such, in the reference 8th read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of ADE/Telecom and DE/Telecom have undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotions ordered from the earlier panel dtd.27.10.2016 for promotion of ADE/Telecom as DE/Telecom shall also be required to be re-drawn.
- 4. Therefore, the earlier panel dtd. 27.10.2016 drawn for promotion of ADE/Tel., as DE/Tel., has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the promotions ordered in the reference 2nd read above, since the said promotions ordered therein were subject to the conditions as extracted at Para-2 above. Accordingly, the promotions ordered in respect of the following ADE/Telecom as DE/Telecom is hereby cancelled with immediate effect:
