ORDER:

Whereas, in the reference 1st read above, under Reg.14(a)(1) of TSTRANSCO SRs Part-II, the following 6 (six) Assistant Divisional Engineers(Telecom) were promoted temporarily as Divisional Engineers (Telecom) from the panel drawn on 09.06.2017, keeping in view the exigencies of work and to suit administrative convenience:

- 2. The above promotion order was issued under Reg. 14 (a) (1) of APSEB Service Regulations Part-II as adopted by TS Transco subject to the following conditions:
 - (i) The promotions are temporary and liable for termination at anytime without notice and without assigning any reasons thereto;
 - (ii) The promotions are subject to outcome of the Judgement in WP No. 16660 of 2015 and batch pending in Hon'ble High Court which is subject matter of CA No. 11435/2018 & Batch in the Hon'ble Supreme Court and also subject to outcome of Contempt Case (C) D.No. 28852/2020 in MA No. 1270/2020 in CA No. 11435/2018 & Batch.
 - (iii) The promotions are subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.

- (iv) The promotions shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotions.
- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 8th read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of Assistant Divisional Engineers (Telecom) has undergone significant change, necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotions ordered from the earlier panel dtd.09.06.2017 for promotion of Assistant Divisional Engineer(Telecom) as Divisional Engineer(Telecom) shall also be required to be redrawn.
- 4. Therefore, the earlier panel dtd. 09.06.2017 drawn for promotion of Assistant Divisional Engineer (Telecom) as Divisional Engineer (Telecom) has been redrawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the promotion ordered in the reference 1st read above, since the said promotion ordered therein were subject to the conditions as extracted at Para-2 above. Accordingly, the promotion ordered in respect of the following Assistant Divisional Engineers(Telecom) as Divisional Engineer(Telecom) are hereby cancelled with immediate effect:
