5. The promotions ordered in para-1 above are also subject to finalization of allocation of employees between AP Transco and TS Transco based on the outcome of the SLP No.9243/2018 of the Hon'ble Supreme Court of India and subsequent changes in the seniority, if any.
6. The promotions ordered in para-1 above are also subject to the condition that they shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between the successor States by the Government and the persons, so promoted meanwhile, shall not have any right on such promotion.
7. The posting orders to the above Assistant Engineers/Civil on their promotion as Assistant Executive Engineers/ Civil will be issued separately.
